### WINPACCS server

#### WINPACCS manager

WINPACCS manager is offered per ASP (Application Service Providing). The monthly charge for the basic module is € 30. This includes one client, five WINPACCS manager users and the complete administration of financiers, as well as country and currency tables.

The following monthly charges will be incurred for using additional WINPACCS manager functions:

- Administration of additional clients: € 25 per client
- Administration of additional WINPACCS manager users: € 0.50 per user
- Administration of project master data: € 0.50 € per active project
- Administration of chart of accounts: € 20 for the first chart of accounts, every additional chart of accounts or sub-accounts € 0.50
- Administration of items and warehouse locations: lumpsum € 20
- Administration of licences and installations: as part of the maintenance charge without additional costs, without maintenance contract € 0.30 per licenced module of the WINPACCS suite and work station

The number of users, clients, etc will be determined monthly. On this basis, fees will be calculated monthly in arrears.

#### WINPACCS communication

WINPACCS communication is offered per ASP. Usage will be charged from 01.01.2012 at €1.70 per month per licenced module of the WINPACCS suite and work station. The service to exchange licencing information is already covered by the maintenance charge. WINPACCS communication may only be used as a package for all licenced WINPACCS modules of an organization.

#### WINPACCS integration

WINPACCS integration allows a direct link from the WINPACCS system to other applications, i.e. ERP-Systems like SAP or MS Dynamics and company's accounting systems.

Information about the prices for using WINPACCS integration can be obtained upon request.

### Maintenance charges

Licensing fees include the maintenance charge for 12 months from the date of purchase. In each subsequent year the maintenance charge will be due. The annual maintenance charge includes the updates to all available new developments and modifications. Excluded are substantial extensions of the functionality or major technology shifts.

The annual maintenance charge for single and company licences is 18 % of the currently valid licence fee of the application. For single licences, it is calculated according to the number of licences purchased and paid annually in advance. Maintenance for company licences is billed in arrears at 1.5% monthly of the respectively current individual licence price (equates to 18% annually), calculated according to the number of licenced modules of the WINPACCS suite and work station installed by the company.
